3. Ordinance Adoption - Zoning Reclassification

Adopt an Ordinance for the land use zoning reclassification from C1-1, Neighborhood Commercial, to C2-1, Regional/Community Commercial, and amending the zoning map to reflect the reclassification. Ordinance Introduction date: August 20, 2018, File #2018-541.

4. Statewide Ballot Measures and Legislation - Recommendations

Approve the recommendation of the Legislative Committee to support Propositions 1, 2 and 3 on the November 6, 2018 statewide ballot; oppose Proposition 6; and take no position on the remaining propositions.

5. Fire Services Joint Powers Authority Agreement - Amendment

Adopt a Resolution, as amended, to authorize the City of San Mateo City Manager to amend the Joint Powers Authority (JPA) Agreement between the cities of Foster City/Estero Municipal Improvement District, San Mateo, and the Belmont Fire Protection District to establish the San Mateo Consolidated Fire Department (SMC) to add Section 19 "Fiscal Responsibility" language and modify Section 15 to reflect a revised 10-year date of January 1, 2029.

6. Rochester Street and Ottawa Street Reconstruction - Agreement

Approve an agreement with Redgwick Construction Co. for the Rochester Street and Ottawa Street Reconstruction Project in an amount not to exceed \$2,294,440; establish a contingency reserve of \$230,000; and authorize the Public Works Director to execute this agreement in substantially the form presented and issue change orders within the contingency reserve.

7. 385 1st Avenue - Lease Assignment

Approve a lease assignment from Redkix to Facebook for the property located at 385 1st Avenue and authorize its execution by the City Manager.

NEW BUSINESS

8. Child Care Development Policies and Options

Heather Stewart, Senior Management Analyst with Community Development Department, provided an update on opportunities to help increase the number of childcare spaces in San Mateo and asked for policy direction from the Council. Council had no questions of staff.

Public Comment - David Fleishman, 4Cs of San Mateo County, provided information on the County's oversight. Christine Padilla, Build-Up Initiative, introduced herself as new director of the Build-Up Initiative for the County and stated the importance of child-care and pre-school options. Jean-Marie Houston spoke in support of bolstering child care initiatives in the General Plan. Prinsess Futrell, Executive Director, Home and Hope, stated access to affordable childcare is critical for a healthy community. Rev. Penny Nixon, stated appreciation for including faith-based organizations in this effort and urged approval of revisions to the policy to release funds to help this move forward. Healther Cleary, CEO Peninsula Family Services, spoke about the importance of early education. Barbara Pavicic, St. Andrew's Lutheran Church, cited the need to close the gap on building improvement needs to upgrade buildings to offer childcare. Adriane Kirk, San Mateo Union High School District, stated interest in partnering with the city for high school students to train childcare providers.

Council was in support of the ideas mentioned and looks forward to having a specific list for feedback the next time this is brought forward.

City Council policy direction is requested to review and amend the existing childcare language in San Mateo's General Plan to further support the inclusion of childcare in future development; and to revise and establish an Interim Child Care Development Fee Policy to facilitate the expenditure of existing funds while other policy work is in development.

REPORTS AND ANNOUNCEMENTS

The City Manager, City Attorney and Council Members reported on their various assignments and liaison roles. Council, by consensus, agreed to bring forward a discussion on the need for a downtown festival as part of the Downtown Plan. Deputy Mayor Papan identified that next year is the 125th anniversary of the founding of the City of San Mateo, and asked for Council member's interest in forming a committee to honor that milestone.
