STUDY SESSION

2. <u>Sidewalk Vendor Regulations</u>

Bahar Abdollahi, Assistant City Attorney, provided a presentation on issues associated with vending of food and merchandise on City sidewalks and parks. She outlined the issues with the State's new laws versus the City's ordinance with regard to sidewalk vending.

Council Member Goethals joined at 6:22 pm. Council asked questions of staff.

Council options included: 1) do not regulate sidewalk vending; 2) regulate sidewalk vending as permitted by the new State law and either (A) enact time, place and manner restrictions on sidewalk vending; or (B) establish a permit requirement for sidewalk vending as a way of registering vendors and imposing time, place and manner conditions; or 3) choose not to comply with the new State laws by arguing that they do not apply to San Mateo as a charter city.

Public Comment: Stan Watkins stated concern with sidewalk vendors in residential neighborhoods. Drew asked if this includes food vendor trucks. Ms. Abdollahi clarified that it does not. Jordan Grimes commented on how great street vendors are for the local economy.

Council discussed the options and by consensus agreed with option 1 - to not regulate sidewalk vending.

3. Corporation Yard Master Plan

Due to time constraints and the need to start the regular meeting, this item was adjourned at 6:49 p.m. upon motion by Goethals, second by Freschet and carried unanimously by vote of the City Council to continue the item upon the conclusion of the regular meeting at 7:00 pm.
