2. Protest of Minor Wireless Permit Approval at 201 North Amphlett Boulevard

Tracy Scramaglia, Senior Engineer, presented the report and asked the Commission to hold a public hearing to consider a protest of a minor wireless permit and uphold the Director of Public Works' decision. Caio Arellano, Assistant City Attorney, was also available to answer questions.

3. <u>Proposed Verizon Master License Agreement for Use of City Owned Poles</u>

Tracy Scramaglia, Senior Engineer, presented the report and asked the Commission to review the proposed Master License Agreement with Verizon, Inc., provide comments to staff, and make a recommendation to the City Council. Caio Arellano, Assistant City Attorney, was also available to answer questions.

Maureen Cruzen, Municipal Engagement Specialist for Verizon, also made a presentation.

Public Comment:

Erika Powell asked that the proposed site at 903* 9th Avenue be relocated to an alternate location.

Laurie Watanuki had concerns about proposed sites at 712 E. 4th and 903* 9th Avenue. Asked if the 9th Avenue site could be relocated to a commercial area.

*903 9th Avenue site was later confirmed by Ms. Scramaglia, Ms. Powell, and Ms. Watanuki, to actually be 803 9th Avenue.

Motion by Robbins, seconded by St. Clair, to recommend to the City Council that Modus/Verizon will be able to install small cell facilities on City-owned street light poles but will still need to obtain Wireless Communication Facilities permits and follow all requirements of the ordinance, including noticing for neighborhood meetings and conditional approval by the Director of Public Works, as well as allowing the public to appeal the Director's decision.

4. Building Demolition Polychlorinated Biphenyls (PCBs) Program Update

Sarah Scheidt, Environmental Compliance Manager, presented the report and asked the Commission to receive an update regarding the City's progress developing a new building demolition program to reduce the discharges of polychlorinated biphenyls in stormwater.
