Wastewater Treatment Plant Immediate Action Projects - Package II - Agreement

### RECOMMENDATION

Approve an agreement with Myers & Sons Construction, LLC for construction of the Wastewater Treatment Plant Immediate Action Project - Package II in an amount not to exceed \$6,340,000; establish a contingency fund of \$634,000; and authorize the Public Works Director to execute the agreement in substantially the form presented and issue change orders within the contingency.

## **BACKGROUND**

The Clean Water Program includes improvements to the wastewater treatment plant (WWTP) to eliminate sanitary sewer overflows and unauthorized discharges. Immediate Action Projects provide rehabilitation to an aging WWTP facility with components dating back to the 1930's and 1950's. To maintain continuous WWTP operations in the event of single points of failure, additional solids processing equipment, piping, and controls are required. This construction package will install large diameter buried concrete pipe, a centrifuge, multiple pumping systems, and a sludge hopper, and includes sludge tank cleaning and other piping improvements.

In accordance with Municipal Code section 3.60.030, a competitive public process was used to obtain bids for this service. A Notice Inviting Sealed Proposals and Bidding Documents was issued to advertise the project on September 16, 2018. Bids were received and opened on October 19, 2018, with the following results:

Contractor	Bid Amount
Myers & Sons Construction, LLC	\$6,340,000
Anderson Pacific Engineering Construction, Inc.	\$6,990,000
Disney Construction, Inc.	\$7,095,000

The low bid of \$6,340,000 is 9.4 percent below the engineer's estimate of \$7,000,000. Staff recommends awarding the agreement to Myers & Sons Construction, LLC based on staff's determination that Myers & Sons Construction, LLC is a responsive and responsible bidder.

### **BUDGET IMPACT**

The agreement award is in an amount not to exceed \$6,340,000. Sufficient funding for this agreement and the \$634,000 contingency is available in Project 46T009 - Immediate Action Project Package II.

#### **ENVIRONMENTAL DETERMINATION**

The City Council approved the San Mateo Clean Water Program and Certified the Final Program Environmental Impact Report on June 6, 2016. Furthermore, in accordance with California Environmental Quality Act (CEQA) Guidelines

section 15301, this project is categorically exempt from CEQA as an 'existing facility' in that it involves negligible expansion of use, because it is maintaining an existing facility. The scope of work falls within this exemption because it involves addition of equipment that will backup existing equipment in event of failure or maintenance.
